Many of you are wondering which products require these labels. Generally *any* prepared commercial, canned, or frozen product for which you are crediting the meat /meat alternate in the product as part of the meal <u>requires a CN label</u>.

If you serve these products <u>and wish to credit the meat/meat alternate in the product</u>, please save the CN label. In the event of a home review, these labels must be on hand for review.

Examples of products that require a CN label in order to credit the Meat or Meat Alternate as part of the meal:

- Commercial Pizza /frozen pizza
- Canned or frozen casseroles containing meat, such as lasagna
- Frozen burritos
- Canned or frozen products containing meat, such as beef stew, ravioli
- Frozen pot pies

If you would like to serve these products, and not worry about CN labels, simply serve an additional meat/meat alternative, such as a slice of cheese, a hard -boiled egg, yogurt, etc.

Costco Chicken Nuggets and Fish Sticks Update:

Chicken nuggets and Fish Sticks ALWAYS require a CN label. **Many of the products sold at Costco DO NOT have the label, and the Disney Chicken Nuggets currently in the stores no longer have the label.** It is important to be familiar with the label, and check to be sure it is there. Providers report finding Chicken Nuggets and Fish sticks which do contain CN labels in Fred Meyer and Winco stores.

Reminder

LUNCH MEATS, DELI MEATS, are currently NOT creditable with CACFP, OTHER THAN THE EXCEPTIONS LISTED BELOW. These products contain binders and fillers and would have to contain a CN label to be credited and currently NONE DO.

UPDATE!!!!

EXCEPTIONS: Frankfurters which contain NO BINDERS OR FILLERS ARE CREDITABLE. Hebrew National Brand Frankfurters which contain no binders or fillers are creditable. Bologna which contains NO BINDERS OR FILLERS is creditable. HAM AND TURKEY HAM, AND HAM AND TURKEY HAM LUNCH MEAT ARE CREDITABLE.

Meats and Meat Alternatives That Do Not Require CN labels:

Eggs, Cheese, Peanut Butter, and Other Nut Butters, Tuna, Beans and Legumes*Nuts and Seeds, count as only half a serving of meat /meat alternative at lunch or dinner; *Cottage Cheese (a TWO OUNCE serving of cottage cheese equals ONE OUNCE of meat/meat alternative.)
